Through our county-wide food recovery program, ExtraFood constantly surveys the needs of our county's nonprofit food programs, finds donations of excess food from businesses that match those needs, posts those pickups/deliveries online, and our 200+ volunteers sign up to pick up and deliver the food to our recipient partners. We operate 365 days a year and our service is free of charge. ExtraFood helps Marin's nonprofit food programs serve more people, serve people more robust and healthy meals, and shift food program funds to their other, critically-needed services. ExtraFood also recruits nonprofits to start new food programs - 18 thus far - expanding the safety net in our county. And, ExtraFood creates synergistic partnerships with organizations that help people lift themselves out of poverty. Finally, ExtraFood gives businesses and organizations a simple way to reduce the massive impact of food waste on climate change. In 2016, ExtraFood organized, recovered, and delivered 436,430 pounds of food - more food than in 2014 and 2015 combined. We delivered this food from 150+ donors, such as grocery stores, caterers, and schools, to 63 sites across Marin, such as senior housing facilities, after-school programs for kids from low-income families, and homeless shelters. We reached more than 5,000 vulnerable people every month with deliveries of healthy, fresh food.
